Public Hearing Local Law D-2023

Local Law No. D – 2023, a Local Law to revise Chapter 100 of the Town Code
Entitled “Zoning” to revise Section 100-42.1 of the Town Code entitled “Short-term
Transient Rentals (STR)”.

Supervisor clarified some questions he received;

This is not a new law; it is redefining definitions. The law was implemented in October
2022. Prior to that, Short Term Rentals were not regulated. No safety inspections, no
occupancy tax collected and neighbors were not notified.

Joan Kelley reiterated defining what is considered a sleeping area.

Bob Pardy, Tina Dr., stated the they have a STR on his street and have problems with noise
and amount of traffic.

Supervisor reiterated to call the Police if there are problems.

Adam Cane, Pancake Hollow Road, the STR of his neighbor is on his right of way and causes
issues.

Bruce Epperson, reiterated the comments from Ulster County Planning Board.

WHEREAS, the Town of Lloyd Town Board, as commissioners of the Highland Water District, have determined that it would be in the best interest of the Town to purchase and install a natural gas powered emergency backup generator to power the Hudson River Pump Station facility during electrical service outages to maintain uninterrupted water supply to the Town's water plant, said funding to be administered by the New York State Division of Homeland Security & Emergency Services, pursuant to Hazard Mitigation Grant Program Project no. 4480-0062, for the Hudson River Pump Station; and

WHEREAS, the Town is in the process of designing the necessary improvements to facilitate and accommodate the installation of the natural gas-powered emergency backup generator; and

WHEREAS, the Town Board wishes to create a project for said improvement.

WHEREAS, one (1) sealed quotation was submitted and opened on February 15, 2024, and

WHEREAS Baker & Sons Landscaping quote \$345.00 per cut for Tony Williams Field/\$80 per cut for the Village Field/\$280.00 per cut for Berean Park/ \$40.00 per hour for extra work; \$1282.00 per application for fertilizing Tony Williams Field/\$648.00 per application for fertilizing the Village Field, and

WHEREAS Baker & Sons Landscaping quote for Spring Cleanup and Fall Clean based at an hourly rate of \$40.00 per hour for: Berean Park, Highland Landing, Hudson Valley Rail Trail Commercial Avenue Property, Hudson Valley Rail Trail Rotary Pavilion, Johnson-Iorio Park, Town Field, Town Hall, Tony Williams Park and Veterans Park, and

WHEREAS a certificate of insurance and non-inclusion certification were submitted, per the Request for Quotation; and,

WHEREAS, the Town's Recreation Director, Frank Alfonso, and the Town Board Agree that awarding the bid for all of the necessary lawn care, including fertilization, would optimize the cost and efficiency of the contract, and the quote for fertilizing submitted by Baker & Sons Landscaping is reasonable and appropriate, and the Town desires to award the bid to Baker & Sons Landscaping, which bid provided for all of the requested services at both Tony Williams Field and the Village Field.

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:

The contract for the Town of Lloyd lawn care for a one (1) year with 2 additional one (1) year options, Beginning March 1, 2024 ending February 29, 2025 for Tony Williams Field, the Village Field and Spring and Fall Clean up at above mentioned locations is awarded to Baker & Sons Landscaping as their bid is considered by the Town Board to be the "best value" for the Town of Lloyd as recommended by Recreation Director, Frank Alfonso.
